Attached is a version of Elliott's letter to Wipke with my inputs. Note that the support of Wipke's communication needs consumes all of (actually a bit more than) our collaborator linkage money awarded for this year. This takes account of Amarel's terminals and phone lines. Also the 4000 page file allocation pretty much uses up the AIM file space allocation (we can still fit Anderson in at 1500 pages). To be sure everyone is really aware of it (I assumed so during the Exec Comm discussion of file space), we have one disk drive (20000 pages) which is not part of the current file system but is used as backup. I want to hold on to this drive for backup as long as possible, given the nature of the TENEX file system.

Dear Dr. Wipke:

I am pleased to tell you that based on the recommendations of the SUMEX-AIM Advisory Committee, the Executive Committee has approved your application for access to Sumex. As you are aware from your discussions with Tom Rindfleisch, there are some problems in accommodating your requirements for resources within our present CPU and file capacities. We have received approval to increase the processing capacity of the system and hope to implement this expansion as soon as possible (vendor discussions are now on-going). At that time we can reexamine the allocation of CPU resources. File space problems will present continuing pressures but we are seeking reasonable solutions through ARPANET large file store facilities which may be forthcoming or other means. Meanwhile your access is based on the following maximum utilization.

CPU time: 22 hours/month total, of which 11 hours are to be used during "non-peak" hours, 18:00 to 09:00 pacific time. We are finishing a batch capability to facilitate such use as much as possible.

Connect time: 430 hours/month

File space: 4000 pages

We can support your communication needs to the extent of one direct telephone line to SUMEX (including 1200/150 baud modem) on an interim basis until you have had an opportunity to obtain grant support for this. Our commitment for dedicated communication support cannot extend beyond our current grant year ending July 31, 1976. At that time we will have to reassess our communications support. You are, of course, welcome to continue using the TYMNET access as you have through UC tie lines. You should arrange the best method of meeting these needs with Tom Rindfleisch.
