

CURRENT LIST OF MEDICAL LITERATURE

CURRENT LIST OF MEDICAL LITERATURE is an index to the current medical periodical literature, published monthly by the Armed Forces Medical Library. Approximately 1400 journals and medical projects reports from all parts of the world are regularly indexed, yielding about 100,000 articles annually. Each regular issue from January through May and from July through November consists of three parts: a Register of Articles, a Subject Index, and an Author Index. The last (June and December) issue of each semi-annual volume is a cumulation of the Author and Subject Indexes of the preceding five numbers.

Register of Articles. Journal issues indexed in a particular number of the Current List are arranged in the Register alphabetically by journal title, the articles listed and numbered according to their appearance in the journal itself. The numbering of articles is begun anew with each volume of the Current List and continues consecutively through the five non-cumulative numbers of that volume.

The full title of each journal appears in upper case as a caption, followed in parentheses and lower case by the location of the editorial office, when this is not indicated by the journal title itself. Directly under the title caption appears the title abbreviation, volume and issue numbers, and date of publication.

Below the bibliographical reference line are listed the articles in order of their appearance

in the journal. All original articles are listed. There is no attempt at qualitative selection. Occasionally, however, an article is omitted from the listing and not indexed if it falls beyond the scope of the Armed Forces Medical Library, and, therefore, of this publication. Omission of articles from the listing and indexing is indicated by an asterisk prefixed to the bibliographical reference line.

Each article entry is composed of a serial number tying it to the indexes, the author or authors of the article in upper case, the title of the article in the vernacular with an English translation, and pagination.

The Current List also indexes Medical Projects Reports. These are, in most instances, near-print reports of research projects accomplished under government contract and issued by the sponsoring agency or institution. These reports are listed, alphabetically by sponsor, in an appendix to the Register, and are indexed by author and subject in the same fashion as are the journal articles.

Subject Index. Subject indexing is done on three levels: a main heading, a subheading, and a sub-subheading or modification. Main headings used are those which appear in the Subject Heading Authority List of the Current List of Medical Literature.* Subheadings are standard

words or phrases representing concepts of frequent occurrence in biomedical literature, and therefore useful for purposes of subgrouping. Most of the subheadings are applicable to a single category of main headings, such as diseases, anatomical parts, or chemical substances, while others are applicable to more than one such category. Operational exigencies prevent the use of subheadings whose meaning restricts them to use under one or a few particular main headings. The modification is derived from the article itself and attempts to give within its limits an indication of the substance of the article. Where large amounts of material under a particular main heading or subheading justify further grouping, simple rules of syntax are observed in the formulation of modifications. An asterisk preceding the modification indicates that reference is to an article in a foreign language.

Author Index. Every author credited by an article is listed in the author index by surname and initials. Articles about an individual (including significant obituaries) are listed in the Subject Index, under the appropriate headings: BIOGRAPHIES, OBITUARIES, etc.

Subscriptions and Distribution. Paid subscriptions are handled entirely by the Superintendent of Documents, Government Printing Office, Washington 25, D.C. and may be placed at any time. The subscription rate is \$12.00 per year, domestic; and \$15.50 per year, foreign. All communications regarding subscriptions should be addressed to the Superintendent of Documents.

Every effort is made to maintain currency, comprehensive coverage, and alert subject indexing of the approximately 1400 journals selected for indexing in the Current List. Users of the index are earnestly requested to share in the work by submitting pertinent comments and suggestions.
