

Thousands suffer without knowing the nature of this almost universal complaint. It is an inflammation or ulceration of the lining membrane of the nasal passages. There are several varieties of Catarrh, with widely different symptoms. The most common kind is characterized by an excessive secretion of mucus or matter in the nasal passages: which must either be blown from the nose, or drops back behind the palate, or is hawked or snuffled backward to the throat.

Other indications are, hawking, spitting, weak and inflamed eyes, frequent soreness of the throat, often ringing or roaring or other noises in the ears, more or less impairment of the hearing, loss of smell, memory impaired, dullness or dizziness of the head, and dryness and heat of the nose.

Often in the first stage but more commonly in the advanced stages there are pains in the chest, or left side and under the shoulder blades.

Indigestion often attends Catarrh bringing in its train many other evils.

There is often hacking cough and the patient's voice frequently changes in tone, talking through the nose as we say. *Some have all these symptoms, others only a part.* Although the leading symptom of ordinary cases of Catarrh is increased secretion of mucus or yellow or greenish colored matter, there is a variety, characterized by dryness and heat of the nose, with the formation of thin scales or crusts in the nasal passages.

This variety is attended with numerous disagreeable symptoms, and is often called Dry Catarrh.

In other cases, the secretion dries in the nasal passages and forms scabs or even plugs in the nose which are often hard to dislodge and sometimes have to be pushed or drawn back to the throat; a sickening process.

OZCENA.

This is a variety of Catarrh in which a vile offensive and disagreeable odor is a prominent symptom.

This odor is caused by the decomposing secretions exuded from festering ulcers far back in the head, sometimes the membrane covering the bones is eaten away and the bones themselves are gradually undergoing decay. Such cases are indeed objects of pity, as the stench from corroding sores reveals to all round, the corruption within, and makes them loathsome even to themselves.

NAMES OF THE DIFFERENT VARIETIES OF CATARRH.

When CATARRH affects the anterior portion of the nose only, where most of the mucus and matter is blown from the nose it is called NASAL CATARRH.

When the posterior Nasal passages are also affected so that mucus or matter drops from behind the palate down to the throat, or has to be hawked backward frequently, it is called POST NASAL CATARRH or NASO-PHARYNGEAL CATARRH.

When the throat and upper part of bronchial tubes are affected, and colds bring hacking cough or hoarseness, it is called BRONCHITIS or BRONCHIAL CATARRH.

Many persons have all these varieties at once.

CAUSES OF CATARRH.

The commencement of most cases of Catarrh is simply as a cold in the head. This does not get well as formerly, and is soon followed by a fresh cold. The frequent repetition of these attacks soon leads to a thickening of the membrane lining the nasal passages, and chronic inflammation is established, with an increasing susceptibility to taking cold on the least exposure.

EFFECTS OF CATARRH.

While Catarrh is primarily a local disease, yet its effects are manifold. From the simple extension of the inflammation downward we have Bronchitis, with its hacking cough and occasional hoarseness and this often ends in consumption.

cure is possible, soon it will transform the features of health and youth into the dark pallid appearance while the hacking cough, the excess of blood gushing from the lungs, or night sweats, all significantly proclaim *it is too late! and thus a neglected catarrh ends in the consumptive's grave.*

As every breath drawn into the lungs must pass over and become polluted by the secretions in the nasal passages it must necessarily follow that poisoning of the whole system gradually takes place, while the morbid matter that is swallowed during sleep passes into the stomach, enfeebles digestion, and often produces dyspepsia.

Again, the inflammation extending from the posterior nasal passages along the Eustachian tubes, reaches the internal ears, producing noises such as roaring or ringing in the head—and eventually impairment of the hearing. It is not uncommon for such persons to lose all sense of smell. The disease advances cautiously until pain in the chest, lungs or bowels, startles him. He hacks and coughs; has dyspepsia, liver complaint; is urged by his doctor to take this or that; and perhaps even cod liver oil is prescribed. Perfectly ridiculous!
