DIRECTIONS.—For the Salt Rheum, Scald Head, or other Humors in the Flesh, annoint the part affected night and morning, and take something for the blood, (Saffron and Yellow Dock are very good.) Cleanse the Sores every morning with clear Soft Water and Castile Soap, and should they discharge abundantly they should be cleansed again at night. If the Sores are tender, warm the water a little, and when it is not convenient to bind them up, melt a small quantity and apply as warm as the patient can bear it. When it can be bound up, spread a soft piece of Linen thinly with the Salve, and bind it on, taking care that the bandage be not so tight as to cause irritation.
