## PREFACE

This list is an outgrowth of a file collected in the Reference Division by many people over a number of years. It has proved so useful that its publication in mimeographed form is now undertaken.

Included in this list are publications about the Library only; the Library's own publications have been purposely excluded. Because of the large number of short articles which have appeared on Garrison and Billings, a selection has had to be made. In general, an article on these men which describes or explains their work in the Library has been included, but one which discusses other aspects of their lives has been omitted. Similarly, the many Congressional bills on the present library building, recorded in the earlier series of the Index-Catalogue, are not cited in this list.

Even within the categories accepted for this list, however, there are probably unintentional omissions. One purpose of putting out this preliminary edition is to invite readers to bring these omissions to our attention so that the final edition can include them.

## THE ARMED FORCES MEDICAL LIBRARY
