

ASTHMA.

None but the sufferer can know the distress which is consequent upon this trying disease. Although it assumes various forms, and does not always observe the same times in making its appearance, yet when it is at its height the suffering is almost beyond endurance. It is common to the young, the old, and the middle-aged, and, in most cases, has baffled the skill of the learned. Although there may not be immediate danger in the attack, yet such is the distress consequent upon its paroxysms, that it may be said with truth that “*life is a burden*.” It is marked by a convulsive, dry cough, shortness and difficulty of breathing, particularly when in an inclined or recumbent position, heaving of the chest and shoulders, rattling in the throat and chest, commonly called wheezing, pale or livid countenance, inability to lie down, coldness of the extremities, gasping for fresh air, great perturbation in the pulse, great distress in the head, the face bloated, the eyes suffused and bloodshot, the bowels swollen and filled with wind, accompanied with belching, feverishness, agitation of mind, apprehensions of death, and oftentimes the whole surface of the body, but more particularly the face and throat, affected with great itching. There is generally an abatement of the symptoms in the morning or fore part of the day, the cough towards the close of the paroxysm becoming loose with expectoration of a glutinous and lumpy mucus, and all the symptoms gradually disappear, but towards night they again increase, and the night is passed in suffering.
